Description Full edition for scientific use. The EOSC-Pillar "National Initiatives" Survey is a cross-section study in Austria, Belgium, France, Germany, and Italy. The survey aims at landscaping national initiatives of open research data and services with relevance to the European Open Science Cloud (EOSC). Four target groups are part of the study: e-infrastructures, research infrastructures, universities and funding bodies. The survey contains questions on the perception of EOSC as well as detailed questions assessing e.g. the e-infrastructures' business models, technical characteristics, access conditions, FAIRness of the data holdings and adopted policies related to open science.




# Invitations et réponses






# Fréquence d'utilisation des services par catégories d'utilisateurs








# Support utilisateurs et formation (e-infrastructures)

- **Support utilisateurs :**  
90% des e-infrastructures en moyenne sur les 5 pays organisent un support pour leurs utilisateurs (94% en France). Dans ce cas, 56% à l'aide d'un système de tickets (72% en France).
- **Formation :**  
77% des e-infrastructures en moyenne sur les 5 pays organisent des formations (84% en France).
- **Langue pour les formations :**  
76% des e-infrastructures en moyenne organisent des formations en langue locale sur les 5 pays (92% en France).  
71 % des e-infrastructures sur les 5 pays organisent des formations en anglais (73% en moyenne en France).







# Familiarité avec les principes FAIR















# Sources de financement des e-infrastructures en pourcentage






# Revenus propres des e-infrastructures
